 - e. promote good conduct and cooperation among members and the public at large at dog-related events and functions.
3. I(we) will never convey any of my(our)dogs to pet shops, wholesalers, or individuals who do not give evidence of being willing and able to care for a dog in a suitable manner, nor will I(we) offer a Pekingese as a prize in any type of lottery or drawing.

Further, I(we) agree that if I(we) fail to adhere to any of the foregoing, I(we) will be subject to disciplinary action by the Board of Governors of the Potomac Valley Pekingese Club.
